Skin protection

Handle with gloves. Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product. The selected protective gloves have to satisfy the specifications of Regulation (EU)2016/425 and the standard EN 374 derived from it.

Body Protection
