4.1 Description of first aid measures

General advice

If inhaled

Call a poison center or doctor if you feel unwell. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. If swallowed

Do not induce vomiting without medical advice. If swallowed, seek medical advice immediately and show the container or label. Do not use mouth-to-mouth method if victim ingested the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

6.1 Personal precautions, protective equipment and emergency procedures

In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and exercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.
