4.1 Description of first aid measures

General advice

If inhaled

Call a poison center or doctor if you feel unwell. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. If swallowed

6.1 Personal precautions, protective equipment and emergency procedures

Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.
